


Practical steps undertaken by Sub-groups to meet Improvement Objectives

- 3. To assure the quality of our protection processes








- 1. Adults at risk benefit from our protection processes
- 2. Adults at risk participate in our protection processes
- Local Adults at risk help set our Committee's Agenda
- 4. Staff benefit from appropriate learning and development
- 5. Staff are confident in the operation of our protection processes







- Benefit is reported via Audit activity and service-user feedback
- 2. There are increasing levels of service-user participation across protection activity
- 3. Local Adults at risk are given opportunities to contribute to the Committee's Agenda
- 4. Staff compliance with required learning is monitored

Realising Outcomes

Work aimed at realising Outcomes is undertaken by our Sub-groups.

These Sub-groups aim to do this by achieving a set of Improvement Objectives (below).







- Develop and monitor an appropriate risk register and highlight risks to HPPCOG as required
- Articulate clear procedures and processes which reflect up to date Codes of Practice and national guidance
- Develop and share best practice and learning including through the completion of formal learning reviews
- To seek service user feedback to understand the impact of our work on protection and participation
- Complete regular multi-agency self-evaluation and audit processes
- Regularly monitor appropriate performance and practice measures to assure quality







- Ensure there are appropriate Information Governance arrangements in place to support practice and the work of Committee
- Engage with local adults at risk to understand their interests and concerns
- Design and deliver a comprehensive, multi-agency training programme
- Promote the awareness of harm to our communities
- Provide clear local guidance for individuals and organisations to report AP concerns
- Address the gaps and facilitate communications and links between adult services and children's services for young people at risk of harm


